Instructions for the Phone Bid form

1. Read the Terms & Conditions either attached to this document or on our Website.
2. If you are viewing this form in your Internet browser or have downloaded the form and are viewing it in [Adobe Reader®](#), proceed to step 3. If this is a printed copy, write in your information legibly and skip to step 4.
3. Type in your information on page 2 of this Adobe® PDF form. For the address, enter your billing address for the credit card provided. If your [Adobe Reader®](#) is the latest version, you can save the completed form to your hard drive, then print the completed form.
4. Sign and date the form in the signature/date section at the bottom.
5. Options for delivering the form:

 - Take a photo of the form and email it to bid@caseantiques.com or text it to 865-408-8805.

Frequently Asked Questions:

- **CANNOT TYPE IN THE FORM** - If you cannot type into the form, print the form and write the information legibly on the form.
- **I WANT TO BID ON MORE THAN 5 ITEMS** - Use multiple forms as needed. Secondary forms only need your name and the LOT #, Description and Bid information.
- **FAX & EMAIL TOTAL PAGE COUNT** - When emailing or faxing the form(s), please indicate the total number of pages being sent on a fax cover page or in the email body.
- **PHONE BIDDER SAFETY BID** - In case we cannot get you on the phone during the auction or the call is disconnected during the bidding process, phone bidders have the option of leaving a “safety bid” on each lot. A safety bid acts like an absentee bid in the case of phone issues. Simply provide your maximum “safety bid” per lot in the Maximum Bid area and we will execute the “safety bid” as an absentee bid on your behalf, if needed.
- **BID INCREMENTS** - These Bid Increments **MUST** be followed on all bids.
